I am directed to state that the Board of Governors at its meeting held on 11.02.2019 considered the Assessment Report (05.06.2018) on the standard of examination and other teaching facilities available at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka for purpose of Renewal of recognition of MD(Pharmacology) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under: -

“The Board of Governors considered the Council Assessor’s Report (05.06.2018) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD(Pharmacology) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.”
