Sir,


In supersession of NMC's letter of even number dated 17.10.2022 on the subject cited above, I am directed to convey the approval of the Competent Authority in the UGMEB to grant Continuation of Recognition with annual intake of 100 MBBS seats as follows:

- (1) *Degree granted on or after April, 2022 by Rajiv Gandhi University of Health Sciences, Karnataka in respect of the students being trained at SDM College of Medical Sciences & Hospital, Dharwad in respect of the students admitted upto the year 2018-19.*
- (2) *Degree granted by Shri Dharmasthala Manjunatheshwara University, Dharwad in respect of the students being trained at SDM College of Medical Sciences & Hospital, Dharwad in respect of the students admitted from the academic year 2019-20.*

2. The following terms & conditions as contained in the Gazette Notification No. MCI- 34(41)/2010-Med./3491, dated 16th April, 2010 titled "Establishment of Medical College Regulations, (Amendment), 2010, shall apply.

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute.*

3. This approval for Continuation of Recognition (100 seats) is granted subject to applicability of amendments in MCI/NMC Regulations from time to time.
